East Fishkill resident receives memorial scholarship in honor of late firefighter

Devan Gehrlein, a firefighter in the East Fishkill Fire District, is this year's recipient of the annual Steven D. Ziskind Memorial Scholarship. Steven was a member of the Wicoppee Fire Company. He died in a motorcycle accident on May 27, 2020.

"My initial reactions to being notified that I am the awardee of the scholarship were feelings of appreciativeness and gratefulness," Devan told Southern Dutchess News last week.

Devan, who is with Hopewell Hose Station 1, remarked, "I had the privilege of knowing Steven for the better part of a decade. Steven was a role model to many and had numerous notable character traits and qualities that all of us should strive to incorporate within our own lives."

Steven is survived by his parents, Polly and Martin "Marty" Ziskind and his brother, Adam.

"By Wicoppee Firehouse bestowing a scholarship in Steven's name on an annual basis, my family can take part in the process to honor his legacy and celebrate his accomplishments," said Polly recently. "It serves as a reminder of the impact he made and the potential he had for a bright future."

Polly noted: "In this way, it keeps his memory alive and creates a lasting legacy. In addition, it can make a positive impact on others, and offer practical support to deserving students."

Devan will be studying at Pennsylvania State University to earn an MBA in Project Management.

"I would like to tell the firefighters and Ziskind family that I am honored and

humbled to have been selected as the 2023 recipient of this scholarship. I would additionally like to thank the Wicoppee Fire Company for their generosity in funding this scholarship in remembrance of Steven. I had the chance to speak to Steven's parents privately prior to the ceremony and expressed my thanks and appreciation to

them during that time," said Devan.

"We deeply appreciate the Wicoppee Fire House immediately establishing a scholarship to honor Steven's memory and continuing to give the scholarship on an annual basis," said Polly.

State reopens Temple Park after 'safe' soil analysis

Temple Park in the village of Wappingers Falls has been reopened, Gov. Hochul announced in release on August 1.

According to the announcement from the press release, "...Temple Park in Wappingers Falls is safe to reopen after soil analysis shows lead levels meet state and federal safety standards for children's play areas." The park was temporarily closed late last month "out of an abundance of caution" stated the Governor's Office, due to media reports that suggested there were elevated lead levels in the soil originating from old overhead lead-containing cables left by telecommunications companies.

"The State's scientific analysis found no evidence of elevated or widespread lead contamination in the area sampled. The multi-agency examination of the potential for lead-based telecommunications cables in New York State communities is ongoing," according to the release.

"My administration will always take swift action to ensure our communities are safe with reports of potential public health threats," Hochul stated. "I am pleased to announce that we have confirmed Temple Park is safe for public use and we will continue our statewide investigation to ensure the continued health and safety of our communities."

"Thanks to the swift action of experts at the Department of Health, the Department of Environmental Conservation, and the Dutchess County Department of Behavioral and Community Health, we are pleased to report that Temple Park in Wappingers Falls is safe for public use. We are continuing our review throughout the state to determine whether there are other areas for concern, and if so, will take immediate action to ensure the health of all New Yorkers is protected," said NYS Health Commissioner Dr. James McDonald in the release.

According to the Governor's Office, "Twenty-five discrete soil samples were taken from and alongside Temple Park, which were then sent to New York State's world-renowned Wadsworth Center for flame atomic absorption spectrophotometry analysis using EPA method 7000B. Field efforts referenced in recent media reports utilized a field instrument, which is a hand-held tool called an XRF machine, to conduct an on-site screening for lead at the park. This tool is useful for screening purposes; however, results should be confirmed with more accurate laboratory analysis of soil samples. New York State requested and has not provided any data or laboratory analysis performed as part of recent media reports."

The release states: "Within the next few weeks, telecommunications companies must provide a full inventory of lead-containing aerial and buried cable owned by the company for both cable still in use to

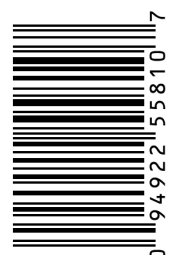


Paul Piastro, left and Ed Moore lead the Security Team at the Dutchess County Fair. They both say, "Our number one objective "is safety of the fair-goers."

Open house held at Dutchess County Office of the Public Defender in the Village of Fishkill

The Dutchess County Office of the Public Defender hosted an open house to celebrate its new satellite office in the Village of Fishkill on August 3. The office, located at 45 Jackson Street, opened in December 2022 and has since served nearly 600 individuals, continuing the office’s commitment to ensuring access to justice and quality legal representation for individuals who cannot afford private counsel.

County Executive William F.X. O’Neil said, “Many who find themselves in the criminal justice system are suffering problems far bigger than their criminal offense – whether it’s untreated mental health issues, substance use disorders, or other challenges. Clients of the Public Defender’s Office receive so much more than just legal representation, instead are helped holistically to resolve issues that may be contributing to their recidivism and help them have a brighter future.”

The Dutchess County Public Defender’s Office is the primary legal services provider for indigent people in need of legal representation in criminal and family court in Dutchess County. Attorneys, social workers, investigators, and support staff collaborate to provide client-centered, holistic legal representation and services. In 2022, the office handled 6,329 cases, including 3,900 cases in the criminal and appellate courts and 2,429 cases in the family courts of Dutchess and Ulster counties. Additionally, attorneys represented individuals at 3,619 arraignments in all Dutchess County criminal courts 24 hours a day, 7 days a week.

The office is under the leadership of

Public Defender Thomas Angell, who has nearly 40 years’ experience practicing law. Mr. Angell joined Dutchess County Government in 1989 and was appointed Public Defender in 2013. He serves as a member of the Dutchess County Criminal Justice Council, where he is Co-Chair of the Jail/ATI Committee and Co-Chair of the Reentry Committee. His work as an advocate for indigent clients and the homeless has been recognized by the New York State Bar Association and National Association of Social Workers.

Angell said, “The Dutchess County Public Defender’s office plays a crucial role in ensuring that every individual, regardless of their financial circumstances, can receive competent and compassionate legal representation. By having a second office with a dedicated staff serving southern Dutchess courts, we can help bridge the gap for our clients who may not have the means to travel to and from our Poughkeepsie location for appointments, further reducing barriers to receiving the help they need.”

The Fishkill office serves clients with cases from the municipal courts of the towns of Wappinger, Fishkill, East Fishkill, Beekman, Dover, and Pawling; the villages of Wappingers Falls and Fishkill; and the City of Beacon. Family Court cases are not handled at this location.

The Fishkill satellite office is in addition to the Public Defender’s offices located at 45 Market Street in the City of Poughkeepsie. To learn more about the Public Defender, visit dutchessny.gov.

New citizens seek opportunity in America after taking Oath of Allegiance in Fishkill

The latest Naturalization Ceremony held in Dutchess County was held at the Fishkill Recreation Center on the afternoon of August 4. Dutchess County Clerk Bradford Kendall and the Clerk's Office organized the event.

The Honorable Jeffrey Martin, who is Dutchess County Family Court Judge and Acting Supreme Court Judge, presided over the preceding.

Martin describes the ceremony as "such a distinguished occasion."

Congressman Mike Lawler, who represents parts of Dutchess, Putnam, Rockland and Westchester counties, offered the keynote address.

Lawler said it is a "momentous occasion" in the lives of the candidates for citizenship.

"You chose to leave your country, your family, your friends," to come to America "for a better life," he said.

Kendall said there were 64 candidates for citizenship and 35 countries represented. Among the countries represented were Antigua-Barbuda, Armenia, Ecuador, Guatemala, Iceland, Ireland, Kenya, Mexico, Netherlands, Nigeria, Philippines, South Africa, Venezuela and Yugoslavia.

Poughkeepsie resident Dinesh Kumar came to America from India approximately 15 years ago.

When asked why he came to the United States, he replied, "It's a great country full of opportunity and respect and dignity for every person."

Kumar responded, "Because I stand for the values of democracy and entrepreneurship and a strong economy that this country has to offer," as to why he decided to become a naturalized American citizen.

Kumar said he applied to become a naturalized citizen last year and that the process took less than a year to complete.

"I'm proud to become a citizen of this great country," Kumar said.

Jadian Simpson, a resident of Poughkeepsie, took the Oath of Allegiance. She came to America from Jamaica.

She said she "really likes" America and came in 2015.

Asked why she decided to become a citizen now, Simpson replied, "It was an opportunity that I always wanted." She said she was excited.

The Oath of Allegiance was repeated by the candidates for citizenship after Kendall spoke the phrases. The Oath includes "...

"We surround ourselves with a great group of professional people. It's a team effort," says Fair CEO Andy Imperati. "We all have the same goal and that's to continue to keep the Dutchess County Fair a safe and fun place."

The security leadership, Ed Moore and Paul Piastro, think of themselves as a part of the Fair's "family." They love their work. Piastro was in charge for 14 years. He retired after the 2022 Fair, but has stayed on as a volunteer aiding the transition to his successor, Ed Moore.

Moore is hardly a stranger to the Fair, having managed the New York State Police presence on site for the better part of 30 years, himself. Paul came to the Fair's family after 30 years with the Dutchess County Sheriff's Office. Ed spent a long career in the New York State Police and, upon retirement, became Chief of Police in Hudson.

"We put in 16 hour days," notes Moore, "but at the end of the day, we still feel great about what we are doing."

"Our number one objective," they both say, "is safety of the fair-goers." Safety at the fair entails a close working relationship with all of the local law enforcement agencies but, also, a close working relationship with the federal weather people up in Albany.

(National Oceanic and Atmospheric Administration - NOAA.) A serious weather event could be a concern here with all of the people, the buildings, the rides and even the trees.

"Violence is almost never an issue at the Fair," said Piastro. "I think we spend most of our interactions with fairgoers telling them how to find the rest rooms."

"We haven't had any serious problems with the fairgoers in a long time," said Moore. "Some years ago, we put a few more controls on the alcohol vendors and that has worked just great. All of the folks serving alcohol undergo "TIPS" training. "TIPS" is a world-wide training program that gives servers the skills to identify and react as needed. It is focused on a community approach to addressing the problems of intoxication, drunk driving, and underage drinking.

In a commitment to making entry to the Fair quicker this year, the prior need to open backpacks and interact with security personnel has been addressed with the installation of new technology. The Fair has added walk-through metal detectors to random gates across the fairgrounds. These metal detectors are set to detect prohibited weapons or other items that are not typically allowed in the Fair.

"Attendees will not have to open their

backpacks, bags or empty their pockets, it's a walk-through experience," said Imperati. "Many large events and venues have gone to the walk-through experience in regard to public safety. Bag check is necessary, but when you have big crowds, the process slows down. We did a lot of research and made sure that we looked at the newest technologies. We hope this process is fast and will get fair-goers into the grounds quicker than the normal bag check process."

As well as an on-site law enforcement presence, the security team at the Fair numbers somewhere between 30 and 40 individuals. "Some are retired from law enforcement," said Moore. "All of them, though, are New York certified security personnel. They are very professional."

Memorable moments One can't manage an operation this big, full of people and of animals without a few memorable moments. "Occasionally on one of the overnights, we might get an animal or two loose," Piastro recalls.

"On at least one night we had a pig running away," said Moore. "The security guards chased it all over until finally one of them tackled it. Neither the guard nor the pig was injured, but we got a good laugh out of it."

After so many years, both men can take satisfaction in their roles. Piastro, recently

retired, said "Everybody who comes here is happy. I love that. Then there are just the great smells and the noises."

"We are part of the Fair's family," said Ed Moore. "We look forward to coming to work. When the week is over, we're exhausted, but feel like we have accomplished something. Every year we make it a little bit better."

Victim's mother files suit against Dutchess County

A lawsuit has been filed against Dutchess County by the mother of a 29-year-old murder victim from Wappingers Falls. On July 31, Rutberg Breslow Personal Injury Law filed a complaint in the Supreme County of Dutchess County on behalf of Cheryl Chianese, whose daughter Melanie was murdered in May 2022 by the mother's ex-boyfriend, Paul Senecal, who was convicted earlier this year of the murder.

"We requested information and documents. Our client did not prefer a lawsuit. We wanted to discuss the situation with county officials, hoping to make the county safer and possibly resolve this sad case without a lawsuit. Instead, we heard from insurance defense lawyers who made clear we would get nothing without a lawsuit. We don't know if they even discussed it with top county officials. They wanted a lawsuit against the county rather than to improve safety and address the harm done here: So that's what they got," Martin Rutberg, attorney for Chianese, told Southern Dutchess News via email on August 4.

According to the lawsuit, Chianese, Melanie, and Melanie's son lived on Scott Drive in Wappingers Falls. It is stated in the lawsuit that in 2021 and 2022 Chianese petitioned Family Court for Orders of protection and extensions of Orders of Protection, which according to the suit, were granted.

"Melanie was stabbed to death by a stalker when she answered her front door, because people at the Dutchess County Probation Department did not do their job," Rutberg said.

He noted: "There was an Order of Protection, there was home confinement and there was electronic monitoring, all so people at the Probation Department could do one thing - make sure the stalker stayed away from the home where Melanie lived with her son and her mother. Instead, they carelessly enabled him to go to the home and kill Melanie."

"We continue to send our condolences to the Chianese family for their loss, and we

stand by the dedicated work the men and women at our Office of Probation and Community Corrections perform every day to serve our residents. Regarding this lawsuit, Dutchess County Government does not comment on pending litigation," a statement from Dutchess County to Southern Dutchess News read.

The lawsuit states that Senecal was prohibited from all communication with Chianese and in the proximity of the property. "Senecal repeatedly violated all orders of protection, was repeatedly found to be in violation of such orders in the Family Court, was more than once arrested, held in the Dutchess County jail and subject to criminal charges in the County Court on account of such violations and criminal conduct."

In or about 2022, it is stated in court documents, that Senecal "be placed in the custody and under the supervision of the Dutchess County Department of Probation." The lawsuit states: "The Dutchess County Department of Probation undertook to monitor Senecal under home confinement and electronic monitoring so as to safeguard Cheryl Chianese, her family and her property."

According to the court document, the county Department of Probation assumed "a special duty of due care" to protect Chianese from Senecal.

The lawsuit alleges "the injuries and wrongful death of Melanie Chianese were caused by the defendant's negligence and breach of its special duty of due care owed to plaintiff Cheryl Chianese."

Chianese demands judgment against the defendant on each cause of action in an amount commensurate with plaintiffs; damages and for such other and further relief as to this court seems just and proper.

"Our clients deserve information, transparency, and accountability. Everyone who lives in Dutchess County deserves that county leadership be informed so they can make correction in the policies, procedures, and training in the Department of Probation, so this does not happen to someone else," said Rutberg.

Community volunteers remember former resident Mary Schmalz

Former Wappingers Falls resident Mary Schmalz died last month in Missouri. She was 89 years old. She leaves her son, Patrick, daughter-in-law and four grandsons.

Mary served as a director of the Wappinger Pop Warner cheer and drill squad. She also was a member of the Wappinger volunteer ambulance corps. She volunteered as a Girl Scout leader. Mary was an active member of the Wappingers Falls Historical Society and the Fishkill Historical Society for many years.

"I recalled talking with Mary one afternoon years ago when our Fishkill Historical Society was having one of our annual Craft Boutiques at the Van Wyck Homestead Museum on Thanksgiving weekend, and Mary was the Greeter - welcoming hundreds of visitors and of course selling hundreds of raffle tickets for \$1 each during the afternoon," said Steve Lynch, Fishkill Historical Society member. "And I recalled her saying that one of her grandsons - who lived in San Francisco, was assigned to do a school report on the song 'Turn, Turn, Turn.' Since Mary Schmalz knew Pete Seeger [late folk singer, activist and Dutchess County resident] personally, and he had composed the song in 1960, she contacted Pete and asked him to write a note to her grandson about it."

Pat explained about that project his son Edward had years back. "Unbeknownst to Edward, my mom asked Mr. Seeger to write a note to Edward outlining how he put together the lyrics for his song 'Turn, Turn, Turn.' Mr. Seeger took a flyer for a concert he and Arlo Guthrie had given a few months earlier at Beacon High School and wrote a note to Edward that outlined his process. Then, either my mom or Mr. Seeger decided it would be a good idea for Mr. Seeger to write a separate note to Edward's teacher, and I provided the teacher's name and mailing address.

"Mr. Seeger then took another concert flyer and wrote a note to Edward's teacher. My recollection is it said something addressed personally to the teacher commending him for being a teacher in a challenging world. Edward's teacher was extremely happy to receive his own personal note from Pete Seeger, especially since he had been a life-long fan!

"Thanks to my mom's willingness to ask, and Mr. Seeger's generosity, Edward got an 'A' on his project," explained Pat.

Cindy Latino, past president of the Wappingers Falls Business & Professional

Association, in a letter to the Schmalz family stated: "She always enjoyed being in the middle of an event in the Mesier Park, whether it was a concert in the park, Halloween celebration, Christmas Tree Lighting or The Joseph McDonald 5K Run. During the last few years that she was out and about in her blue van, she became my sous chef at the annual McDonald Run."

Beth Devine, with the Wappingers Historical Society, said, "Mary was a force to be reckoned with. She was involved in many community organizations, especially if it had to do with history. Among them, she belonged to three or four Historical Societies." Devine remarked, "Mary was kind - and she was one of a kind. She made an impact wherever she went."

Jack Fedigan stated, "There are so many memories I could share with you about Mary Schmalz. Mary was an integral part of The Wappingers Village Historical Society, the Town of Wappingers Historical Society and the Town of Fishkill Historical Society. It is not an understatement to say Mary was a visionary. She understood the need to preserve the past to inform the future." He said, "Mary helped preserve items that made a real impact." He noted The Bleachery, which he and his brother began years ago, Schmalz helped to preserve a timeline about it.

"Mary will be truly missed by our greater Wappinger community. Her persistence and motivation to help others has made this Town and Village a better place. Often an avid and vocal person, Mary always had the best interests of her neighbors at heart. Whether she was coaching Cheerleading, volunteering on the Recreation Commission to expand soccer programs, advocating for Greenway programs, or welcoming visitors to historic sites on the Ramble, Mary's impact on Wappinger and Wappingers Falls will be felt for many years to come. We thank her for all of her volunteerism and pushing us all to be the best we can possibly be," said Joseph D. Cavaccini, Dutchess County Legislator and Wappinger Town Historian.

Christina Contelmo, with Meals on Wheels in Wappingers Falls, said, "Our Meals On Wheels volunteers would bring The Southern Dutchess News to clients on Thursdays. If we forgot Mary's copy we had to go back and get one and bring it to her later, as she had her subscription copy sent to the Veterans at Castle Point. She was involved and interested in all and anything about our community. She was a great asset to her 'hometown.'"

DCHS's big move part of larger plan

Editor's note: In place of our regular "Decoding Dutchess Past," we present a special message this week from Dutchess County Historical Society Board President, Rob Doyle.

So much has happened in the first six months of the year, I'd like to provide an update on the positive news on many fronts.

Many of you know that the Dutchess County Historical Society goes from strength to strength in what some have called a revival or renaissance. We recently published our 101st volume of The DCHS Yearbook, the longest serving historical journal in New York State, featuring under-represented histories, "Invisible People. Untold Stories." The Yearbook currently in production and out later this year looks at agriculture. The exhibition of the work of Caroline Clowes at Locust Grove had over 1,000 visitors at the end of last year, telling the story of how a woman in the 19th century succeeded in a man's world of fine arts painting.

What may be less well known, is that since a spectacular year in our 2014 Centennial Year, DCHS has struggled to break even in operating expenses. This started to turn around in 2021. But a complete strategic review by the DCHS board in partnership with the New York Council of Nonprofits yielded a strategic plan that called for profound change. I'm pleased to say we have very quickly made

progress in the two most important areas:

#1. Physical Location Accessibility & Framework for Growth

The Clinton House in Poughkeepsie has been our home since 1979. The historic 18th Century House owned by New York State Parks is in a state of disrepair, exposing DCHS to growing repair and maintenance costs. In addition, it is inflexible in accommodating collections we are delighted to report continue to grow.

We have been able to secure, with a long-term view, a wonderful opportunity in Rhinebeck located right on Route 9 a mile south of the village. It is a recently renovated, entirely ADA compliant building that allows greater and easier access to the public, and room for growth. We will continue to have a presence across the county with traveling exhibitions and programs.

We are lucky to have a real partner in building owner Elijah Bender, who understands the location is a very visible gateway at the south of the village, embedded in a very historic

setting, entirely suitable for our needs, and equally suited the needs of the immediate neighborhood.

Adjacent are intact 18th and 19th century homes of John Benner and General Richard Montgomery's estate, Grasmere. Active farmland is part of the same parcel. Together with Mr. Bender, we will preserve the character that makes Rhinebeck so attractive."

We are very grateful for the accommo-

dation the Arnoff family has shown in helping make this move possible.

#2. Cost of Collections & Archival Preservation / Endowment Growth

The most challenging fundraising we face is covering the costs of our most sacred (but least visible) trust: the careful professional archival preservation of documents, photographs, textiles, and objects.

We benefit from a perpetual legacy fund through Community Foundations of the Hudson Valley left by Denise M. Lawlor who, with her father, were active members across the 20th century. It currently yields about \$11,000 annually.

We set a target of doubling the revenue we can depend on in this way, with a goal of establishing a new \$200,000 endowment. An anonymous donor has pledged \$100,000 that will be given dollar for dollar with a match, so that by the end of the campaign, the endowment will total \$200,000. The principal will not be touched. But the annual yield (which will vary by market conditions) will support costs of collections and archival preservation including a professional manager

staff position. We have not fully announced the campaign and have already raised \$11,000 toward the match so we are optimistic that we can meet our campaign goal by the end of next year.

While we focus on the important work of our move, we would like to ask you to consider what you can do on three fronts:

We are very grateful for – and encouraged by – the positive comments we have been getting about DCHS's revival. The additional news of the progress of the endowment campaign and new location provide the perfect moment to invest in the future by securing what's important from the past.

Ramirez, Velasquez gain honors for Renegades

Talk about having a lock hold on the weekly and monthly awards.

Hudson Valley Renegades catcher Agustin Ramirez has been named South Atlantic League Player of the Month for July. This marks the second straight month that the Renegades have had a player win a monthly award, with Drew Thorpe picking up SAL Pitcher of the Month honors in June.

Ramirez hit an unbelievable .415/.467/.756 in July, leading the SAL in batting average, hits (34), doubles (10), total bases (62), slugging percentage, and OPS (1.223). He finished third in the league in home runs (6) and fourth in OBP. He homered in four straight games from July 23-27, becoming the second Hudson Valley player this year to do so, joining Aaron Palensky.

"Agustin has been great since his call up to High-A and all the work he has put in is on full display," said Renegades hitting coach Kevin Martir. "I couldn't be happier for him."

Playing in 20 games in the month, Ramirez collected 11 multi-hit games, and had an eight-game hitting streak from July 7-20.

The 21-year-old was originally signed by the Yankees as a non-drafted free

agent out of Santo Domingo, Dominican Republic on July 12, 2018. He began the 2023 season with the Single-A Tampa Tarpons before being promoted to the Renegades on June 29.

Renegades bounce back to win series after Blue Rocks ‘walk-off’

The Hudson Valley Renegades ran into a hot relief pitcher and then were “walk-off” victims on Saturday night.

The Wilmington Blue Rocks walked off the Hudson Valley Renegades 2-1 in 10 innings.

But on Sunday, the Renegades came back to grab a 3-1 win to take the series.

In his High-A debut, Wilmington’s Leonardo Pestana was terrific. He retired the first eight hitters he faced before issuing a two-out walk in the third inning to Gerald Diaz. Diaz was the lone man to reach against Pestana, who ended up striking out five in 3.2 scoreless innings.

Andry Lara also kept Hudson Valley off the scoreboard in the first four innings before they broke through in the sixth inning against Chance Huff. Marcos Cabrera walked to begin the frame before advancing to second base on a wild pitch. Spencer Jones grounded out to second to move Cabrera to third before Alexander Vargas hit into a fielder’s choice to score Cabrera when T.J. White’s throw home went wild and hand the Renegades a 1-0 lead.

Wilmington’s Murphy Stehly lined a double down the left field line to begin the seventh against Mason Vinyard. After advancing to third on a wild pitch thrown by Vinyard, Sammy Infante hit a sacrifice fly to right field to score Stehly and tie the game at 1-1.

Hudson Valley had a chance to take the lead in the ninth against Todd Peterson. Christopher Familia and Antonio Gomez each tallied back-to-back singles to begin the frame before Peterson struck out the next two batters. Luis Santos worked a walk to load the bases before Peterson punched out Cabrera to leave the bases loaded.

In the 10th, Dannel Diaz (1-4) entered out

of the bullpen and allowed a leadoff single to Jones to place runners at the corners with nobody out with automatic runner Marcos Cabrera advancing. Diaz retired the next three men to strand a pair of runners on base.

Jack Neely (5-3) struck out four of the first six batters he faced in the eighth and ninth before rolling out again for the tenth. Kevin Made grounded out to begin the extra frame before Infante walked to bring up Brandon Boissiere. Boissiere laced a base hit down the third base line to score the automatic runner Jared McKenzie to hand the Blue Rocks a 2-1 victory.

Seven of the 10 runners left on base by Hudson Valley on Saturday were stranded in the final three innings.

The Renegades opened the series with an 8-4 loss last Tuesday night, August 1.

Hudson Valley finished off its 12-game road trip with an 8-4 record. Wilmington plated the game’s first run in the second inning on Sunday off Sean Hermann after Branden Boissiere and Kevin Made tallied back-to-back singles to start the frame. A fielder’s choice by Jared McKenzie advanced Boissiere to third base, who then came in to score on a sacrifice fly from Courtland Lawson to give the Blue Rocks a 1-0 lead. Hermann (1-0) was the third Renegades’ starter to make his High-A debut this series and he turned in a strong outing. The 20-year-old allowed just one run and struck out five in five innings. Between Hermann, Baron Stuart on Wednesday and Leandro Pestana on Saturday, the three debutantes combined to allow just one run across 14.2 innings while striking out 15.

The Renegades are home for the next two weeks with games against Jersey Shore and Brooklyn.

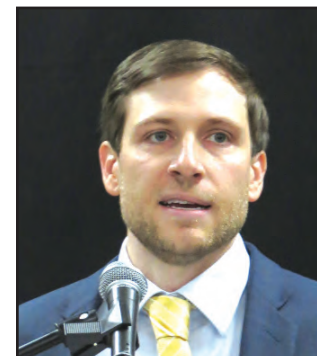
thing further his brand and recognition. It should be a lot of fun!

provide service and cable that is no longer being used but has yet to be removed."

DOH, DEC, and DPS will use this information to evaluate the need for additional steps, including identifying any sensitive locations to prioritize for further investigation, and will keep communities informed as these efforts advance, according to State officials.

"Public safety is a core mandate to the Commission and I am proud of the speed with which the state agencies and county partners conducted the requisite testing to meet that mandate and ease community concerns. We will continue to work with our partners to take necessary actions to protect communities and the environment," stated Rory M. Christian, NYS Department of Public Services CEO.

According to the Governor's Office: "Lead naturally occurs in soils, and typical lead soil levels range from 50 to 400 parts per million (ppm). In addition, lead can be found in paint in older homes, dust, air, water, soil, and in some products used in and around our homes. Lead-based paint in pre-

1980 homes is the leading contributor to elevated blood lead levels in children. The acceptable limit for children's play areas, per EPA soil guidance levels, is set at a maximum of 400 ppm. All but one sample collected by DEC and DOH at Temple Park and nearby areas contained lead below this range. The sole exceedance, at 410 ppm, was located along the roadway and outside of play areas and does not present an exposure concern to children or the general public."

"In response to reports of historic lead cables at Temple Park, New York State agencies partnered with Dutchess County and the Village of Wappingers Falls to quickly advance a comprehensive sampling plan. The results of the State's sampling should give parents and Wappingers Falls residents peace of mind that park visitors are safe from lead exposure. DEC continues to work closely with the Departments of Health and Public Service, and local partners to fully assess potential risks from lead cables and take necessary actions to protect communities and the environment," said Basil Seggos, New York State Department of Environmental Conservation Commissioner.

In memory of Ken Jennings (1919-2007) and Les Hadden (1915-99)

Sixty years ago a group of energetic, fun-loving, and talented young teenagers from Wappingers Falls accomplished a remarkable feat – they won the New York State Senior Little League Championship.

It was a TEAM effort all the way, as the Falls men used the pitching heroics of Ron Paino and Gunnar Locke, clutch hitting, and strong defense to win six consecutive contests to claim the crown.

This was only the third year of competition for the senior program in Wappingers. Ken Jennings and Les Hadden were excellent coaches, long-time supporters of youth sports, and respected community leaders.

The All-Star Team consisted of 14 players – John Cadou, Joe Canale, Matt "Cookie" Dielt, Wayne Dodson, Bob Dunkly, George Foster, Jim Fulton, Ken "Bub" Jennings, Pete Kozlak, Gunnar Locke, Ernie Martin, Bob Major, "Rapid" Ron Paino, and Bill Sneyd. Tony Maccarini and David Eckert were alternates.

Wappingers opened the tournament on July 23 with a 16-0 win over Fishkill at The Bleachery's Temple Field. Paino

struck out 12 and had three hits while Major homered and singled. Cookie Dielt and Jim Fulton added two hits and two runs apiece. On July 26, the Fallsmen defeated host Kenisco 7-6 in Valhalla thanks to a four-run sixth inning. Locke was the winning pitcher while Dunkly (who contributed a triple) gained the save.

The All-Stars took their next two outings playing in the shadows of Yankee Stadium, 9-6 over Green Point on July 27, and 5-2 over Tre-Ford on July 30 in the District 17 final. Both contests were held at Macombs Dam Park in the Bronx. Hitting stars included Cadou, Dielt, Dunkly, and Foster. Canale made a nice defensive play to end the game with runners on base against Green Point. Locke and Paino each picked up their second victory on the mound.

Moving to the NYS semifinals, Wappingers scored seven runs in the fifth inning in a 9-1 win over host Penfield on Aug. 2. Foster and Major provided two-run hits in the inning and Paino notched his third pitching victory.

In the State title games, Gunnar Locke had a game to remember as he pitched a no-hitter and hit a dramatic walk-off home run with one out in the bottom of the seventh inning in a 1-0 win over Stoney Creek (Ontario). Locke and Larry Mackie were

involved in a scoreless dual until Locke's blast gave Wappingers one of the town's biggest victories ever.

The Champs received a hero's welcome upon their return home as Mayor Peter C. Furnari said, "We are extremely proud of the honor, recognition, and distinction brought to Wappingers Falls and the immediate area by our Little League Senior Division. We are particularly proud too of the players who displayed the highest ideals of sportsmanship and fair play."

Locke, who grew up just across the street from The Bleachery, summed it up the best by proclaiming the State title was "a team effort."

At the Eastern Regional in Rhode Island, Dielt came through with a game-winning RBI single in the bottom of the sixth in a 3-2 victory over West Chester (PA) on Aug. 9. Cadou gave the Fallsmen a 2-0 lead with a two-run single in the third. Rapid Ron (the nickname given to him by the late Southern Dutchess News sportswriter Doug Heady) had two hits and was the winning pitcher out-dueling future major-leaguer Jon Matlack. Paino finished with a 4-0 pitching record.

Wappingers' memorable season came to an end with a 4-0 loss against Pompton Lakes (NJ) on Aug. 10. The day wasn't a complete disappointment, however, as team

members attended a picnic hosted by Hall of Fame player and four-time World Series champion Frankie Frisch. Falls resident George Schlathaus arranged the visit with his famous relative.

The All-Stars were honored during a parade in the Village on Aug. 19 as part of Little League Recognition Day. Former Wappingers Board member Albert Canale, uncle of All-Star Joe Canale, served as the event chairman. Tommy Holmes, the former baseball great of the Boston Braves, was the guest speaker. Holmes told the players, "Your fine performance on and off th

e field is a reflection on the wonderful job your coaches (Ken Jennings and Les Hadden) have done during the season."

The All-Stars had another thrill when the New York Yankees honored them at the Stadium on Aug. 28 in the Bronx, just a short distance from where they won two games a few weeks earlier.

The All-Stars are now in their early to mid-70s and thankfully all are still alive. Joe, Ron, Ernie, and Bub (in the summer) reside in the area. The rest are scattered around the country. Many served our nation, and many have children and grandchildren. Memories fade over six decades, but mention the 1963 state title to this group, and they are teenagers again happily reliving one of the best times in their lives. They will be forever linked thanks to their friendship with one another and one mighty swing of the bat by their beloved teammate, Gunnar Locke.

Broccoli di Rabe and Provolone Sandwich Ingredients

- White bean purée:
- 6 tablespoons olive oil, divided
- 3 garlic cloves, thinly sliced
- 1/2 teaspoon crushed red pepper flakes
- 1 15-ounce can cannellini (white kidney) beans with liquid
- Salt, freshly ground pepper

Sandwiches:

- 4 bunches broccoli rabe, ends trimmed
- Salt
- 1/2 cup olive oil, divided, plus more
- 1 head of garlic, cloves peeled and

thinly sliced

- 1 1/2 teaspoons crushed red pepper flakes

- Freshly ground black pepper
- 8 6" long sub rolls, split lengthwise
- 8 ounces thinly sliced sharp provolone

Preperation

For white bean purée:

Heat 3 tablespoons oil in a small saucepan over medium-low heat; add garlic and red pepper flakes. Cook, stirring often, until garlic begins to turn golden, about 4 minutes. Add beans with liquid. Bring to a simmer; cook, stirring often, until liquid thickens, about 10 minutes. Transfer to a food processor; add 3 tablespoons oil. Process until smooth. Season with salt and pepper.

For sandwiches:

Cook broccoli rabe, adding 1 bunch at a time, in a large pot of boiling salted water for 2 minutes. Drain and transfer broccoli rabe to a baking sheet; let cool. Squeeze dry; coarsely chop.

Heat a large pot over medium heat; add

1/4 cup oil, garlic, and red pepper flakes. Cook, stirring often, until garlic is beginning to turn golden, 2-3 minutes. Add broccoli rabe; cook, stirring often, until stem pieces are just tender, 4-5 minutes. Add remaining 1/4 cup oil. Season with salt and pepper. Spread out on a rimmed baking sheet and let cool.

Preheat to 400°F. Open rolls and arrange on 2 rimmed baking sheets. Drizzle with oil. Spread bean purée on one side of each roll; add broccoli rabe. Top with cheese. Toast until cheese is melted, 7-10 minutes. Put both sides together, slice, and serve.

New varieties and pollinators

A sneak peek at what's on trial for 2025



On one of our trips to look at new flower varieties, Sue and I were ushered into a restricted garden to take a sneak peek at new varieties being trialed for 2025. Our phones and cameras were impounded. This was at Lucas Greenhouses in Monroeville, N.J., last Wednesday.

Over the years we've gotten to know some of the top breeders in the ornamental horticulture industry. On this occasion, Dr. Alican Carlson, technical services director for Syngenta, showed us a new vinca bred for disease resistance, a petunia call "Painted Love," and a sunflower with double blossoms.

I couldn't help but notice that bees, mostly honeybees, were swarming on all the blossoms except the new double sunflower. A few years ago, a double coneflower was introduced that sported blossoms so compact and tight that bees could not get in to sip the nectar. That coneflower "Secret Passion" gave rise to the perception that modern breeding was one of the factors causing a decline in pollinator populations.

Why do breeders create new varieties? Do we really need a yellow petunia? Call it fashion - do we need a new style of handbag, or a new movie, or a new flavor of Cheerios?

But vegetable and flower plant breeders are more than fashionistas. They're breeding for disease resistance, heat and cold tolerance, and ability to survive in slightly salty water. I was at a corn breeding

discussion where the main concern was whether 55 ears would fit in the standard size box. The University of Florida came out with a sugar enhanced sweet corn (not GMO) so corn shipped from Florida would taste good a week after it was picked. Even small-scale market garden farmers are in on the act. New lettuce varieties are bred to look good at Farmers Markets. And now you don't have to spray your monarda and phlox for powdery mildew. The new varieties are resistant.

Aside from the new double sunflower and double coneflowers, I've seen bees on all kinds of blossoms - native (asters and joe-pye weed), introduced (clover, daisies, zinnias) and even invasive (purple loosestrife). Native bumblebees especially go for catmint. Lots of different pollinators love applemint and mountain mint. And honeybees (themselves not native,) are crazy about the invasive porcelain vine. A well balanced garden or wild meadow will support bees whether the plants are native or not.

Now let's talk about butterflies - the other big pollinator. Adult butterflies will feed on just about any flower. Monarchs seem to be attracted to tithonia. I had a giant tiger swallowtail on the zinnias. Skippers, black swallowtails and painted ladies flit back and forth over the blossoms in our garden, new and old varieties alike. But the caterpillars - now that's a different story, and it makes a very good case for maintaining native

plants. Most caterpillars, which are the larvae of the butterflies, feed on a specific host plant. Here is a list of some of the most common ones:

- Monarch - Milkweed
 - Black Swallowtail - Queen Anne's Lace, parsley
 - Tiger Swallowtail - Wild black cherry, magnolia
 - Painted Lady - Thistle, aster, sunflower
 - Skippers - Black locust, honeylocust
 - Viceroy - Cottonwood, willow, aspen
 - Cabbage Butterfly - Cabbage, broccoli
- Note that the common white cabbage

butterfly is not native. It came from Europe and would not be able to survive in the U.S. on strictly native plants.

As we wound up our private tour of the 2025 test garden, Dr. Carlson asked Sue if she could think up a name for the new double sunflower. She came up with "Midas Touch." I suggested "Bee Killer." Check your seed catalogs in a couple of years to see whose suggestion won out.

once owned by the influential Verplanck family. Tours will be offered at 11 a.m. and 1 p.m.

Elaine Hayes is the executive director of Mount Gulian. "The garden has a variety of perennial and annual flowers and plants, some of which were in the garden more than 100 years ago. Depending on the time of year, visitors will see roses, irises, lilies, fraxinella, dahlias, trumpet vines, peonies, and yucca," Hayes remarked.

During the tours, visitors will learn about the garden's origins, and evolution. According to Mount Gulian information, the site has gardeners Mary Anna Verplanck and James F. Brown as notable gardeners. Mary Anna was described as "a precocious eleven-year-old, designed the original 1804 garden." Brown was "an enslaved man who fled Maryland and worked as Mount Gulian's master gardener." There was also Virginia Eliza Darby Verplanck whose literary contributions

include two gardening books, "Every Day in My Garden" and "A Year in My Garden" from the early 20th century, said Hayes.

"The garden is intended to be enjoyed in the spring, summer and fall, so anytime during these months is a good time of year to visit. Boxwoods, cosmos, dahlias, nicotiana hybrids, butterfly weed, echinacea, snapdragons, and grasses are in bloom now," said Hayes.

Admission to this special tour is: \$12 adults; \$10 seniors; \$6 youngsters (6-18 years). Children under 6 and Mount Gulian members are free. Members of the public may sign up to become members.

A RESOLUTION AUTHORIZING, SUBJECT TO PERMISSIVE REFERENDUM, THE PURCHASE OF UPGRADING, AND IMPROVING PIPES, PUMPS, WELLS, AND APPURTENANCES IN THE TOWN OF EAST FISHKILL, DUTCHESS COUNTY, NEW YORK, AT A MAXIMUM ESTIMATED COST OF \$16,728,196., AND AUTHORIZING THE ISSUANCE OF \$16,728,196 BONDS OF SAID TOWN TO PAY THE COST THEREOF.

WHEREAS, the capital project hereinafter described, as proposed, has been determined to be an Unlisted Action pursuant to the regulations of the New York State Department of Environmental Conservation promulgated pursuant to the State Environmental Quality Review Act and Findings Statement will not have a significant adverse effect on the environment; and

WHEREAS, it is now desired to authorize such capital project and its financing; **NOW, THEREFORE, BE IT RESOLVED**, by the Town Board of the Town of East Fishkill, Dutchess County, New York as follows:

The faith and credit of said Town of East Fishkill, Dutchess County, New York, are hereby irrevocably pledged for the payment of the principal of and interest on such bonds as the same respectively become due and payable. An annual appropriation shall be made in each year sufficient to pay the principal of and interest on such bonds becoming due and payable in such year unless paid from other revenues. There shall annually be levied on all the taxable real property of said Town, a tax sufficient to pay the principal of and interest on such bonds as the same become due and payable.
